About my MBE Award

Just before Christmas 2002, I received a letter from The Foreign & Commonwealth Office dated 19th December, informing me that this honour was conferred on me - 'by Her Majesty in recognition of (your) services to the charity RoadPeace'.

My MBE ceremony was held on 25th March 2003 in the Houses of Parliament in a beautiful room accessible from Westminster Hall and was attended by very many RoadPeace friends, my daughter, personal friends and co-campaigners, many MPs from our APPG including Andrew Miller, its chair, and the German Ambassador. The award was presented by Lord Falconer, at the time Minister at the Home Office, later Lord Chancellor, who said it was the first time he had performed such a task.

I learnt that RoadPeace patrons and board members had applied for my award during the Summer of 2000. The following are quotes from the many letters of application.

When my husband was knocked from his bicycle by a motorist at the end of March 1996, our lives changed for good and I was devastated. My husband suffered a fractured scull and was left registered blind, with other effects of brain injury. The fight for compensation was horrific and we often felt like giving up and so alone....A year after the crash I read about RoadPeace in a magazine and contacted the organisation. It was such a relief to talk to people who had been through similar experiences and knew exactly what we suffered....The help and support I received gave me the will to go on fighting. Much of the support came personally from Brigitte, who I later found out, had started RoadPeace after the death of her son in a road tragedy. Out of her grief came a helping hand for other road victims. I was amazed that someone so dedicated and busy as Brigitte could spare time to ring me up and encourage me to talk, sometimes in my darkest moments.....When my husband's claim was settled, I applied to work on the helpline, received training and in 1999 began the work. I am often in tears myself and cannot begin to imagine how Brigitte had managed so long, almost alone — the emotional strain alone must have been enormous....I am proud to be associated with a person so dedicated to helping victims of road crashes and want to go on working with the team she has inspired and who also gives so much of herself.

....I have only known of the work of RoadPeace for two years....I was giving a paper on the psychological impact of traumatic incidents on physical and psychological functioning of victims. Brigitte wanted to know more about my work and invited me to meet with her and some of the other members of the organisation. What I saw was remarkable. At that time RoadPeace was run from Brigitte's home. There was one paid worker and a mass of other people involved in providing an extremely comprehensive support service for fellow road crash victims. I first knew Brigitte Chaudhry shortly after RoadPeace was formed. With a background in transport, I was invited to be a Transport Adviser. I came to chair the organisation for several years during the mid-late 1990s. Currently I am Vice Chair and Transport Adviser.....Brigitte Chaudhry's achievements have been immense.....RoadPeace, from the smallest and most tragic of beginnings, has become a respected charitable organisation whose views are sought by government ministers, civil servants, magistrates, lawyers, transport organisations and the police....the undoubted driving force behind the success of the organisation has been Brigitte Chaudhry. At first, she tried to persuade other organisations to take up the cause of road traffic victims. But as no organisation did so, she set up RoadPeace....Without RoadPeace a lot of road traffic victims would have been left floundering with no advice or support. Without RoadPeace, a number of transport organisations would not understand road victms' concerns. Without RoadPeace, the issue of road traffic victims would be much further down the political agenda. Without Brigitte Chaudhry, there would have been no RoadPeace.

Having worked in the criminal courts for almost thirty years, I have sadly been aware of where in my view the system fails those that is is supposed to serve — victims and their families....The failure of the system has been particularly acute in cases involving death on the roads....By chance, in the early nineties I met Brigitte Chaudhry, who was clearly determined to do something about those whose lives had been devastated by a road death and the way in which the police and courts worked....Since that time I have been involved as a patron of RoadPeace and have seen Brigitte Chaudhry's working methods and infectious enthusiasm.
